

LCM CLOSES LCM 33 CLO

NEW YORK, August 12th, 2021 - LCM Asset Management LLC announces the close of a \$509.2 million collateralized loan obligation (CLO). The Class A notes are rated Aaa (sf) by Moody's and bear interest at three-month LIBOR plus 1.14%. LCM EURO LLC, an affiliate of LCM, is acting as collateral manager for the CLO.

The CLO, called LCM 33, includes:

- A \$315.0 million Aaa (sf) rated Class A tranche with a coupon of 114 basis points over Libor;
- A \$65.0 million Aa2 (sf) rated Class B tranche with a coupon of 165 basis points over Libor;
- A \$27.5 million A2 (sf) rated Class C tranche with a coupon of 200 basis points over Libor;
- A \$32.5 million Baa3 (sf) rated Class D tranche with coupon of 320 basis points over Libor;
- A \$20.0 million Ba3 (sf) rated Class E tranche with coupon of 635 basis points over Libor;
- A \$49.2 million equity tranche.

LCM is staffed with senior professionals with significant experience in leveraged lending as well as relevant industry specialties.
