

## LCM CLOSSES LCM XVII CLO

NEW YORK, October 15, 2014 - LCM Asset Management announced that it closed on a \$410.5 million collateralized loan obligation (CLO). The most senior notes are rated AAA(sf) /AAA(sf) by Standard & Poor's Ratings Services and Fitch Ratings Inc, respectively, and bear interest at three-month LIBOR plus 1.45%.

The CLO, called LCM XVI Limited Partnership, includes:

- A \$255 million AAA(sf) rated Class A tranche with a coupon of 145 basis points over Libor;
- An \$29 million AA(sf) rated Class B-1 tranche with a coupon of 205 basis points over Libor;
- An \$24 million AA(sf) rated Class B-2 tranche with a coupon of 4.36%;
- A \$22 million A(sf) rated Class C tranche with a coupon of 275 basis points over Libor;
- A \$18 million BBB(sf) rated Class D tranche with a coupon of 350 basis points over Libor;
- A \$20 million BB(sf) rated Class E tranche with a coupon of 475 basis points over Libor;
- A \$42.5 million equity tranche.

LCM Asset Management LLC ("LCM") was established in 2001 to manage client funds through investment funds, accounts or vehicles, which principally include portfolios of senior secured bank loans. LCM is staffed with senior professionals with significant experience in leveraged lending as well as relevant industry specialties.
