

RESET OF LCM XIV LIMITED PARTNERSHIP

NEW YORK, June 6, 2018 - LCM Asset Management LLC announces the \$432.7 million refinancing and extension of a cash flow CLO backed by broadly syndicated senior secured loans and managed by LCM Asset Management LLC. The Class A notes are rated Aaa (sf) /AAA (sf) by Standard & Poor's Rating Services and Fitch Ratings Inc., respectively, and bear interest at three-month LIBOR plus 1.04%.

The CLO, called LCM XIV Limited Partnership, includes:

- A \$5.1 million AAA (sf) rated Class X-R tranche with a coupon of 60 basis points over Libor;
- A \$256.0 million AAA (sf) rated Class A-R tranche with a coupon of 104 basis points over Libor;
- A \$47.5 million Aa2 (sf) rated Class B-R tranche with a coupon of 158 basis points over Libor;
- A \$22.25 million A2 (sf) rated Class C-R tranche with a coupon of 185 basis points over Libor;
- A \$23.0 million Baa3 (sf) rated Class D-R tranche with a coupon of 275 basis points over Libor;
- A \$19.25 million Ba3 (sf) rated Class E-R tranche with coupon of 550 basis points over Libor;
- A \$8.0 million B2 (sf) rated Class F-R tranche with coupon of 761 basis points over Libor;
- A \$51.57 million equity tranche.

LCM is staffed with senior professionals with significant experience in leveraged lending as well as relevant industry specialties.
